Penn for Immigrants Rights (PIR) is a successful and prominent leader in the Philadelphia area. PIR is the first organization at the University of Pennsylvania led by undocumented youth and allies looking to increase dialogue on immigration in the United States. They hope to engage the Philadelphia community in conversations regarding equal access to higher education for immigrant students regardless of their current immigration status, undocumented students are strongly encouraged to apply. Their priority is to empower undocumented students and immigrant communities.

The Penn for Immigrant Rights Scholarship was established to **provide funding for Philadelphia college-bound high school students regardless of their immigration status**. This \$500 scholarship would be granted to select Philadelphia students following an application process evaluated by the Scholarship Committee of Penn for Immigrant Rights. PIR hopes this scholarship fund may also help undocumented students, otherwise ineligible for most types of financial aid towards education.

- Must be a current high school senior OR a high school graduate
- Must be enrolled in an institution of higher learning the academic year following the scholarship award

- Your Immigrant Story\*
- Personal Statement\*
- **Transcript** Submit most current high school transcript. You may submit an unofficial or official transcript.
- Letter of recommendation You may submit only one (1) letter of recommendation. If an applicant submits more than one, ONLY ONE will be read.

\*PIR recommends that the applicant considers having someone proofread your essay prior to submission

- 1. Send only application materials listed above.
- 2. All materials must be mailed, delivered in person, or <u>uploaded here</u> in one piece by 11:59 PM on March 15, 2020.
  - $\rightarrow$  If mailed, the application must be postmarked to the address below.
- 3. Incomplete applications will not be reviewed. Applications missing any of the required documents are considered incomplete.
- 4. Awardees will be notified by March 29, 2020. Finalist names will be posted on the PIR website and Facebook page and any other promotional material.
